

Tariff Changes

Effective per 1 January 2018

Postage rates will change per 1 January 2018, while several products will also be modified.

Below you can find an overview of the key changes:

Single item mail – Domestic

- The rate of the 'Nederland 1' stamp will increase by €0.05 to €0.83.
- The rate for Registered Mail will increase by €0.05 to €8.40.
- The rate for letters including Insurance Service will increase by €0.05 to €14.45.

Single-item mail – International

- The rate of the 'Internationaal 1' stamp will increase by €0.07 to €1.40.
- For letters within the 350-2000g weight range, the rates will be €9.80 for zone EUR1; €12.60 for zone EUR2 and €15.40 for the World zone.

Single item parcels – International

- The rates for standard international parcels including Track & Trace will remain unchanged.
- The rates for parcels weighing up to 2kg without Track & Trace will be modified: the rates will be €9.80 for zone EUR1; €12.60 for zone EUR2 and €18.20 for the World zone.
- The rates for international Registered parcels and international parcels with Insurance Service will increase, with the exact increase depending on the parcel's weight and destination.
- International parcels can also be sent by Registered service for an insured amount of up to €100.

Franking machine

- The Franking machine rates for domestic letters with a weight of up to 20 grams will be €0.77.
- The Franking machine rate for international letters with a weight of up to 20 grams will be €1.29.

Business Reply Service

- The rate for the domestic Business Reply Service weighing up to 20 grams will increase by €0.05 to €0.74.
- The rate for the International Business Reply Service weighing 20 grams or less will increase by €0.06 to €1.34.

Change in weight ranges

The 100g-250g weight range will change to a 100g-350g weight range, followed by a 350g-2000g range. This applies, among other things, to franking machine and single item mail sent with stamps or on account (domestic and international).



Changes effective 1 January 2018

Bulk Mail

The tariffs for a number of products will change per 1 January 2018. The products listed below are exclusive of VAT. All international products listed are VAT-exempt. A complete overview of our products, services and rates is available on postnl.nl/tarieven2018.

Domestic Bulk Mail

The rates for Domestic Bulk Mail will increase by an average of 4.5%.

International Bulk Mail

The rates for International Bulk Mail will increase by an average of 3.0%.

Bulk Mail

We invest in our sorting machines in order to ensure that mail delivery in the Netherlands remains affordable and of a high quality. As of 1 January 2018 we will charge a more competitive rate for machinable mail. Please contact your local Account Team to learn if your mail is machinable.

Special Domestic Bulk Mail will be renamed Bulk Mail Large and Bulk Mail Special

- Machinable mail items currently falling within the Special product type will then be classified under the 'Large' product type.
- Non machinable mail items currently falling within the Special product type will then be classified under the 'Special' product type. This means that some mail items may become less expensive for you because they will fall into the 'Large' category.

Periodicals (sorted) will be renamed Periodicals Special (sorted)

- The Periodicals product type includes mail items processed mechanically. Items are either sorted or unsorted when they are dropped off.
- The new Special Periodicals product type includes mail items processed non-mechanically. Items are either sorted or unsorted when they are dropped off.

Miscellaneous

Door-to-door distribution

- The rates for Standard door-to-door distribution will be increased by 2.0% on 1st January 2018.
- The rates for Special door-to-door distribution and Government distributions will be increased by 4.0% on 1 January 2018.

Business services

The rates for a number of products will change as per 1 January 2018. A complete overview of our products, services and rates is available on postnl.nl/tarieven2018.

PO Box subscriptions and Business Reply Service

The standard rates for PO Box subscriptions and Business Reply Service have increased to €199.50 per year.

Business Retention Service and Business Forwarding Service

The rates for the Retention Service and Business Forwarding Service will increase by 5.8% and 5.5%, respectively.

Collection and Delivery Service

- We will be increasing the rates for the Collection and Delivery Service by an average of 3.0%.
- The specific rate change depends on the number of days, the volume, the time period and the type of geographic area (i.e. urban or non-urban) of the delivery address. In 2018, a single daily rate will apply for 1-4 days, plus a single daily rate for 5 days a week. Check postnl.nl/tarieven2018 to see how this will affect your rates.
